- You must prove ownership of your vehicle for the Illinois Secretary of State. **Ownership can be proven with:**
 - **The Title** for the vehicle or,
 - **The Bill of Sale** that is not older than six months old. All Bills of Sale must be signed and dated by the Buyer and Seller. If the Bill of Sale is **NOT** from a dealership, **it must be notarized** or,
 - **The ST 556 Form.**
- Also, **include a 2290 Form if it is applicable** to your vehicle.
- **For Transfers, a copy of the old cab card is required.**
- If your vehicle was previously registered in another State, you will need a copy of that cab card to show continuous registration.

A 45-Day Temporary Permit cannot be issued until all information is completed and the qualifying paperwork has been sent. Make copies of this form for your future use. We appreciate your business!
